Leveraging the funding available through the Canada Digital Adoption Program (CDAP) to your organization's benefit is a journey. From your first conversation about program to the execution of your digital transformation plans, MNP Digital will be your guide.





- Government approval should arrive within 20 days
- Sign your engagement letter with MNP Digital
- You have nine months to develop your Digital Adoption Plan after getting approval

Step four: Apply and receive the grant

- Upload the Adoption Plan and Invoices to the Website
- Receive the grant within a maximum of 30 days
- Gather additional information via interviews, questionnaires, or surveys

Step one: Assess your eligibility and apply Ensure your organization meets the eligibility criteria

- Be incorporated federally or provincially or be a Canadian resident sole proprietor
- Be a for-profit, privately owned business
- Between one and 499 employees
- Between \$500,000 and \$100 million in annual revenue in any of the last three years

Apply online through the CDAP website

- Only the owner or director of your organization can apply
- The process will require a questionnaire and verifying your identity
- It should take 20-25 minutes

Step three: Developing your Digital Adoption Plan

Phase one: Discovery

The MNP Digital team will:

- Review the Digital Needs Assessment report
- Assess the current state of your digital tools and platforms
- Gather additional information via interviews, questionnaires, or surveys

Phase two: Envision

The MNP Digital team will:

- Identify solutions that will enable you to reach your target future state
- Prioritize top three solutions and identify the requirements to implement them
- Estimate the costs of implementing the top three solutions, and the entire strategy

Phase three: Strategy

The MNP Digital team will:

- Provide a clear, detailed Digital Strategy that outlines where you stand and what your future state looks like
- Provide an Implementation Roadmap that lays out in detail how to reach your desired future state
- Present findings and recommendations, as well as answer questions, in a succinct presentation to your organizational leaders

Step five: Loan application

- Organizations who use CDAP are eligible for between \$25,000 – \$100,000 in interest-free loans to implement their Digital Strategy
- If your revenue is under \$5 million, you are eligible for a loan of \$25,000 \$50,000. If greater than \$5 million, the loan range is \$25,000 \$100,000.
- The loans are available through BDC five years interest free and one year for implementation (total of six years)
