

Terms and Conditions: MNP LLP Toronto FC Instagram Contest

All winners selected must answer this skill-testing question: $(2 \times 4) + (10 \times 3) = \underline{\hspace{2cm}}$.

Contest begins on June 3rd, 2019 and closes June 14, 2019 (the “Contest Period”). All entries must be received by MNP LLP (“MNP”) prior to June 14, 2019 by 11:59 pm CST. No purchase is necessary. Two (2) Toronto FC Tickets to the Wednesday June 26th – 8 p.m. Toronto FC vs Atlanta United FC at the BMO Field: 170 Princes' Blvd, Toronto, ON M6K 3C3, Gate 3, total value of \$253.10 to be won.
